

THE SAFETY SECTION

Electrical bicycles ("e-bikes") that belong to a Shipyard owner and have been registered with SPOA are allowed to be operated within Shipyard. Class 1 and Class 2 e-bikes may be registered with SPOA. Any Class 3 e-bikes purchased before December 1st, 2023 will be grandfathered in and have the ability to be registered with Shipyard. Pedal mode is only allowed within Shipyard, and use of the electrical motor is prohibited. E-bikes must be ridden on Shipyard recreational paths only in pedal mode only and not on Shipyard roadways. E-bikes not registered with SPOA may not be used within Shipyard, which includes e-bikes rented from any e-bike vendors, bicycle rental agencies, and owners. Information on the use of e-bikes on Hilton Head Island outside of Shipyard may be found the https://hiltonheadislandsc.gov/pathways/ebikes/.

Slow down and use your turn signals. With cooler weather, walkers cyclists, dog walkers, children, etc. are spending more time outside.

Fishing in Shipyard's lagoons is not permitted. Due to recent activity this past summer, the Board of Directors met in August and voted to continue to ban on

LOCKER RENTERS

If you are currently renting a Beach Locker, you should receive an invoice for 2024 via mail in mid-November.

Payments are due by December 14, 2023 if you intend on continuing your rental.

If you do not intend to renew, please give us a call at (843) 785 - 3310 ext. 1000 or let us know as soon as possible. Your contents must be removed by December 31st.

Keep in mind beach lockers are nontransferable. This means if you were to sell your Shipyard property, the new owner would not be entitled to your current locker. They must enter the waitlist.

If we do not receive word whether you would like to continue your locker rental or not, Shipyard POA will remove your lock and contents mid-January.

LOCKER WAITLIST

If you are patiently waiting on the beach locker waitlist, you should receive a letter in the mail with an updated status by mid-January 2024.

If you do not receive a letter call us at (843) 785 - 3310 ext. 1000.

We appreciate your patience.

The Shipyard POA Team will contact you via phone if a locker becomes available and you are next in line. At this point you will be expected to pay the annual rate and will be issued a locker.

Please provide your own beach supplies and lock.

VEHICLE DECALS

NEW Decals & Beach Hangtag for 2024 will start on Monday, December 4th.

- To register all vehicles, bring vehicle registrations and proof of insurance (even if the vehicle has previously been registered with the POA)
- Bring a completed form and your state or federal
- Forms are available now for your convenience. They can be picked up at the Welcome Center or either gate

DISCARD YOUR 2023 BEACH HANGTAG & VEHICLE DECALS

- Decals and hangtags cannot be obtained via phone, mail, or email
- Limit 2 decals (no charge) and 1 beach hangtag if primary residence is not in Beaufort County
- Limit 4 decals and 1 beach hangtag if primary residence is in Beaufort County

THANKSGIVING SAFETY

When you are using the stovetop, stay in the kitchen to keep an eye on things. Start with a clean oven and make sure to stay in the house and check on it from time to time. Keep anything that can catch fire away from your stove – potholders, wooden utensils, or paper towels.

Make sure your sleeves are out of the way when cooking. Wear tighter fitting clothing or shorter sleeves.

Make sure things like knives, electric cords from appliances, matches and lighters are out of a child's reach.

Remember that steam or splash from vegetables, gravy or coffee can cause serious burns. Keep those pot handles turned in!

Have activities that keep kids out of the kitchen during this busy time. Games, puzzles or books can keep them busy. Let kids get involved in Thanksgiving with recipes that can be done outside the kitchen or without cooking.
